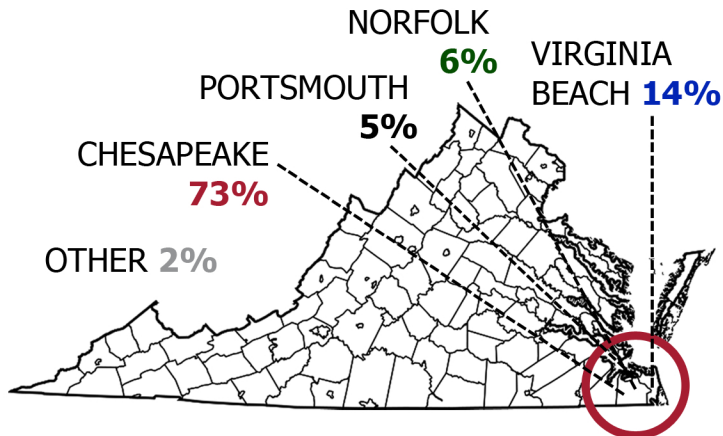

Chesapeake Care Clinic is a 501(c)(3) non-profit organization with a rich history of compassion and commitment. Established in 1992, we have been providing medical and dental care for the underserved for over 28 years.

We recognize medical and dental care are basic needs that are not affordable and accessible to everyone. Even with Medicaid expansion and the Affordable Care Act, there is still a massive gap in healthcare coverage. In Virginia, many people are asset limited, income constrained, and employed but cannot afford health insurance.

Chesapeake Care Clinic strives to bridge the gap in healthcare by providing affordable, high quality care to the low-income and underinsured in our community.

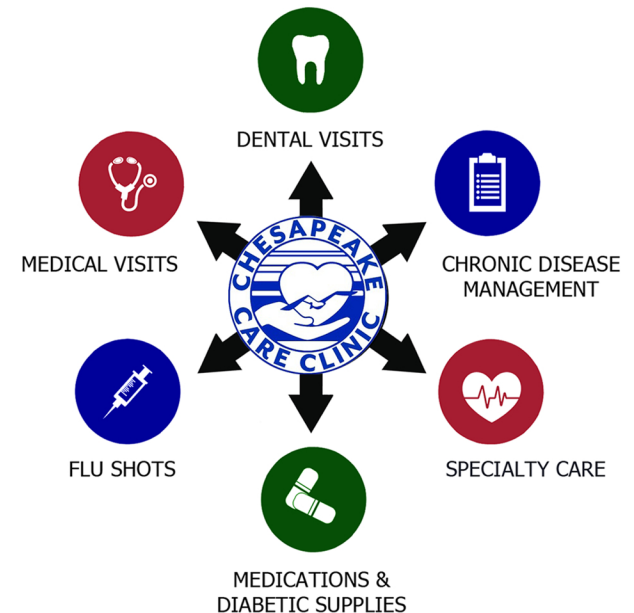

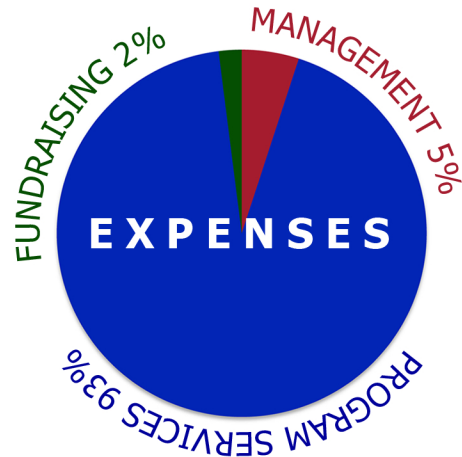
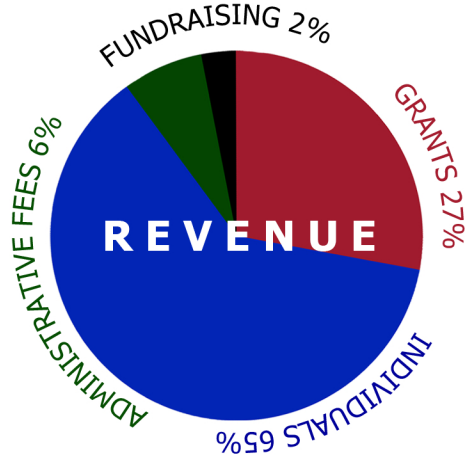
## CHESAPEAKE CARE CLINIC serves the underserved.

Tammy has been a patient at Chesapeake Care Clinic since 2007. Tammy's place of employment doesn't provide health insurance and she cannot afford it. Tammy is one of the 77,000 uninsured adults in Hampton Roads.

About 12 years ago, Tammy went to the emergency room and was diagnosed with diabetes. After four days in the ICU, Tammy was referred to Chesapeake Care Clinic. Since becoming a patient in 2007, she has benefitted from countless medical and dental resources the clinic offers. She says, “Chesapeake Care Clinic has been my life saver.” Tammy receives specialty care including endocrinology, ophthalmology, gynecology, pulmonology, and sleep apnea. She also utilizes diabetic nurse education and high blood pressure education to help manage her chronic illnesses. She is able to pick up affordable medication and diabetic supplies through the clinic's medication assistance program and claims that “without Chesapeake Care Clinic and the help that they offer me, I would not be here today.”
